Set Up Time

- Set up time will be from 1:00 PM - 4:00 PM on Friday, July 20.
- Vendors will be allowed access to the designated Vendor Parking Area (limited to 1 per vendor). Additional vehicles must be parked in the General Public Parking areas.

Festival Hours

Vendors must hold their booth open to the public during the following festival hours:

- Friday, July 20, 5 PM - 9 PM.
- Saturday, July 21, 1 PM - 9 PM

Tear Down Time

Vendors must tear down after the event ends on Saturday evening (approximately 9 PM) and must be finished by 10 PM. All trash is to be placed in the trash receptacles provided. Vendors must clean their area completely.
